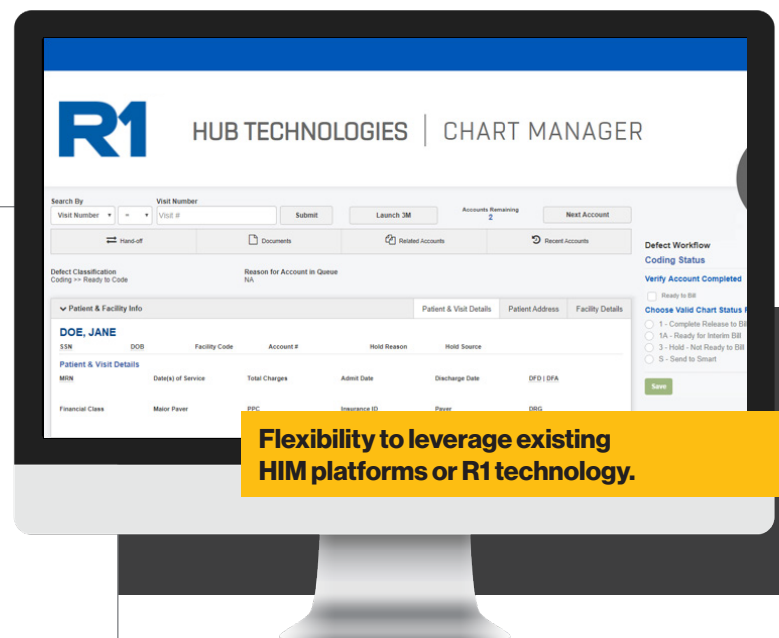

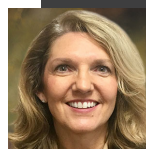


Quality Management
