MAJOR CHANGES TO BILLING CODE G0511

In January 2024, The Centers for Medicare and Medicaid services (CMS) announced major changes to the reimbursements for care management of rural health supported patients.

Now, Federally Qualified Health Centers (FQHCs) and Rural Health Clinics (RHCs) can **bill multiple instances** of General Care Management Code G0511, which includes Remote Patient Monitoring and Chronic Care Management, per patient per month.

Eligibility: G0511 is most often used for Medicare patients with two or more chronic conditions (Medicare Advantage patients are also eligible, while Medicaid and commercial payers are more limited in eligibility).


We created a comprehensive, easy-to-deploy solution to deliver digital healthcare to your patients, providing end-to-end setup and support.

Risk Stratification: We pull EMR data, identify eligible patients (even pulling ICD-10 codes) and set them up in RCP.

Patient Enrollment Assistance: We provide mail, email, outbound calling, and an innovative appointment program. You don't have to change anything you do today in order to enroll patients and we get an up to 40% take rate for eligible patients.

Patient Onboarding: We ship needed equipment to your office or directly to the patient, get them fully set-up, develop a care plan and assign them to a nurse coach. We also do a surescripts data pull to track medication.





Nurse Coaching Assistance: Each RCP nurse coach works with a panel of approximately 200 patients, monitoring patient adherence and readings, frequently interacting with patients. They can even set up appointments and set up medication refills.

Claims Management and Revenue Assurance: We create the claim files needed for billing and will assist with revenue assurance.

Population Health Reporting: Physician and organization level detailed reports are provided from us each month. These reports highlight patients doing better and those needing ongoing assistance.
