# The Challenge

Avail Health needed to execute a large-scale Hierarchical Condition Category (HCC) recapture initiative across the entire state of West Virginia to ensure Medicare Advantage risk-adjusted reimbursements accurately reflected patient acuity. This required completing over 1,500 Comprehensive Disease Assessments (CDAs) across 40+ skilled nursing facilities in a matter of weeks with an operation with multiple layers of complexity which created significant scheduling and coordination challenges:

**Dual Deployment Models:** Avail simultaneously launched two distinct clinical models: an in-person nurse practitioner model and a hybrid model pairing an in-person nurse with a virtual nurse practitioner. This innovative approach allowed Avail to scale clinical resources across multiple states while maintaining high touch care at the bedside.





# Field-Based Risk Adjustment Operations

- Multi-Stakeholder Coordination: Every patient assessment also required the presence of a health plan member advocate. These advocates lived in different regions and covered members across separate facilities, adding another layer of logistical complexity to scheduling.
- Statewide Scale: Clinicians needed to be deployed to facilities spread across an entire state, with minimal lead time to train and launch teams.
- Data Accuracy and Documentation: Beyond completing assessments, the operation needed to accurately update historic ICD-10 codes, resolve outdated diagnoses, and improve the plan's risk adjustment factor (RAF) scores.

Legacy tools like spreadsheets, emails, and basic EHR scheduling could not handle the sheer scale or complexity of this project. Without a purpose-built solution, the risk of missed assessments, inaccurate documentation, and lost reimbursement revenue was high.

#### The Coordinista Solution

Coordinista partnered with Avail Health to execute a statewide yet highly efficient HCC recapture initiative:

- Centralized Coordination with Decentralized Execution: Enabled NPs and nurses to self-deploy and engage with their assigned members while maintaining operational oversight.
- Dual-Model Deployment: Seamlessly supported both clinical models, coordinating in-person and hybrid teams across state lines.
- Integrated Scheduling: Coordinated clinician visits with health plan member advocates, ensuring advocates were present for every assessment despite their dispersed locations.
- Rapid Training and Launch: Trained and deployed 16 clinicians across 8 states in under a week, enabling immediate operational launch.
- Qualitative ICD-10 Insights: Tracked over 16,700 historic codes, identifying which were replaced with more specific codes, resolved, or deferred due to missing data—providing actionable insights to improve documentation fidelity.
